Holiday Lighting / Contract




Midway City Holiday Lighting Contract:

The Christmas Light Professionals (CLP) will provide holiday lighting services for Midway City for the following three holiday seasons 2022, 2023, and 2024 under the terms of this contract.

Scope

CLP will install lights on one 80 ft. tall pine tree, four smaller pines, the trunks of eight pines, and 37 deciduous trees (see map.) In addition, CLP will provide all lights, extension cords, and equipment needed for this holiday lighting service with approximately 40% more coverage on the deciduous trees and small pine trees than installed in 2021 (but not 80' pine). If any trees are removed those lights will be distributed amongst the other trees or on a like-size tree.



Maintenance

If there are any performance issues with the lights or installation problems, it will be the city's responsibility to contact CLP via our main number, 801-355-0111, or email info@thelightpros.com. We will perform maintenance work within 48 hours of contact.

Time frame

Lights will be installed between October 1st and November 15th and removed each season between March 15th and April 7th. Starting in the fall of 2022 and final removal in the spring of 2025.

Cost

The cost of said lighting service will be \$30,525.99 per year. Midway City will receive a discount of \$3,647.03 each year. The grand total will be \$26,878.96 each year (see attached estimation). Midway City will also receive a one-time credit of \$5,000 as a buyback for their old lights. If for any reason, Midway City wishes to terminate the said contract before the 2024 holiday season, they would be responsible for paying back the pro-rated portion of the \$5,000 buyback for old lights (\$1,666.70 per year).

Additions

If the city wishes to add trees to the Holiday Lighting project, they may do so at any time by requesting additional trees. These trees will be bid out with similar coverage and cost as the other trees, and upon approval by the city, they will be added to the project.

Product

All lights and extension cords used on city property will always remain property of CLP and will only be leased for seasonal purposes. If for any reason, extension cords or lights are vandalized or stolen, it will be the city's responsibility to replace said product's cash value.
