#### **ITEM: 11**

Berg Engineering, agent for SC Partners and Ryan Davis, is proposing a General Plan Amendment. The proposal is to amend the City's Road System Master Plan and remove part of a planned connection of 600 North between Pine Canyon Road and Farm Springs Road.

#### **BACKGROUND:**

Berg Engineering, agent for SC Partners and Ryan Davis, received conditional approval for a General Plan Amendment August 8, 2020. The proposal was to amend the City's Road System Master Plan and remove part of a planned connection of 600 North between Pine Canyon Road and Farm Springs Road. Further, the City had adopted Ordinance 2012-22 that showed the alignment for the future road. The required condition for the Road System Master Plan Amendment was that the Ryan Davis property would need to be deed restricted to a maximum density limit of three lots. The Farm Meadows Density Reduction Subdivision has now been recorded and all three lots have deed restrictions that prohibit any further subdividing. Since the

condition has now been met, the City can proceed and adopt ordinance 2023-10 that officially removes 600 North from the City's Road System Master Plan. The ordinance will also rescind Ordinance 2012-22 that had adopted a specific alignment for 600 North.

#### **PROPOSED FINDINGS:**

- Deed restrictions have been recorded on the three lots in the Farm Meadows Density Reduction Subdivision.
- Ordinance 2012-22 will be rescinded with the adoption of Ordinance 2023-04.
- The General Plan will be amended, specifically, the City's Road System Master Plan will be amended, and 600 North will be removed as a future planned road across the area of the Farm Meadows Subdivision.

## ORDINANCE 2012-22

### AN ORDINANCE ADOPTING AN AMENDMENT TO THE MIDWAY CITY ROAD SYSTEM MASTER PLAN MAP

WHEREAS, Utah Code Section 10-9a-407 authorizes municipalities to adopt official maps; and

WHEREAS, the City Council of Midway City finds that certain amendments to the current Midway City Road System Master Plan Map are necessary and will serve the public interest.

**NOW THEREFORE**, be it ordained by the City Council of Midway City, Utah, as follows:

Section 1: Pursuant to Utah Code Section 10-9a-407, the Midway City Road System Master Plan Map, attached hereto as Exhibit A, is amended to reflect, include and incorporate by reference the alignment of the proposed public road known as 600 North Street as shown on the site plan attached hereto as Exhibit B and the aerial map attached hereto as Exhibit C.

Section 2: This ordinance shall take effect upon publication or posting as may be required by law.






AN ORDINANCE TO AMEND THE ROAD SYSTEM MASTER PLAN IN THE MIDWAY CITY GENERAL PLAN TO REMOVE THE PLANNED SECTION OF 600 NORTH FROM PINE CANYON ROAD TO FARM SPRINGS ROAD.

WHEREAS, Midway City has adopted a Road System Master Plan within its General Plan that governs all roads that have been or are planned to be constructed within the City; and

**WHEREAS**, the Road System Master Plan currently contains a planned connection of 600 North between Pine Canyon Road and Farm Springs Road; and

WHEREAS, Ryan Davis, the owner of the property where the planned connection would be removed, is proposing the amendment in light of the fact that if his property is developed, the road connection will not be required or necessary; and

**WHEREAS**, Mr. Davis is proposing that if the City approves the road connection removal, he will only develop his property as low density in order to preserve open space for the City.

**NOW THEREFORE**, be it ordained by the City Council of Midway City, Utah, as follows:

The planned road connection of 600 North between Pine Canyon Road and Farm Springs Road shall be removed from the Midway City Road System Master Plan on the following conditions:

- Potential density must be reduced;
- Mr. Davis must work with City Staff to find an acceptable solution for a two-lot plan;
- The City Council may consider revising the qualifications for a rural preservation subdivision to potentially allow three lots on Mr. Davis's property in the future;
- Mr. Davis must work with City Staff to deed restrict the property to a maximum of three lots before the road connection is removed from the Plan.

Ordinance 2012-22, which originally adopted the planned road connection of 600 North between Pine Canyon Road and Farm Springs Road, is hereby rescinded.

This ordinance shall take effect upon publication as required by law.
